A direct debit mandate is concluded with the payer for the collection of membership fees (see sheet 2). The membership fee is payable quarterly and is collected by SEPA direct debit at the beginning of the quarter. Changes in bank details, address or contact details must be communicated immediately to the board or treasurer. All fees incurred in connection with a return debit note are to be borne by the payer. The 1st reminder of possible outstanding debts is free of charge. For the following two written reminders, the signatory undertakes to reimburse the association with fees of € 5,- each, as well as all actual costs incurred for the reminder procedure from the third written reminder onwards.

Notification of health restrictions and proof of health & fitness:

Health restrictions and regular intake of medication must be reported to the trainer/supervisor by the member, in the case of minors by the legal guardian, prior to training sessions or competitions. For participants in competitions, a proof of health & fitness (certificate/examination) by a licensed doctor is required, which must be presented to the trainer annually without being requested.

Withdrawal / termination notice period: Withdrawal is only possible at the end of the 1st and 3rd quarter of a calendar year with a notice period of 6 weeks and after a minimum membership period of at least one year from the date of entry. The notice of resignation must be sent in writing to the Executive Board (for addresses, see footer or www.aqua-kids.biz).

Data processing DSGVO: The member(s) and the signatory (legal guardian for your children) agree that his/her data will be stored and processed for club and competition purposes in paper form and electronically. The club will use the data exclusively in the context of club administration, club events and for necessary association and competition registrations. Personal data will not be passed on to third parties in any other way. Membership is only possible with the approval of data processing.

Permission to photograph: The signatory authorizes the publication of photos / videos of training sessions, competitions and events for club purposes. Photos / videos will be made available by the club exclusively for the reporting of the club (including homepage, press, internal communication) and online as well as the coaches / trainers / members and, in the case of minors, their parents. The permission to publish photos / videos can be withdrawn in writing at any time, or by crossing out this passage.
